### Scope of Practice Standards, Limits, Conditions

#### Introduction

This document contains information regarding Naturopathic Doctors' (NDs) scope of practice as set out in the *Naturopathic Physicians Regulation* (Regulation) under the *Health Professions Act*. Additional scope of practice information is included in the College of Complementary Health Professionals of BC (CCHPBC) Bylaws and Standards of Practice.

**Part 1** sets out the scope of practice standards.

**Part 2** sets out limits and conditions related to restricted activities and the naturopathic doctors scope of practice.

**Part 3** sets out limits and condition on activities that are not restricted

Information in this document is subject to change as CCHPBC policy is revised or legislation is amended. CCHPBC registrants will be notified of changes.

## Part 1: Scope of Practice Standards

The **Scope of Practice Standards** are based on the activities that NDs can carry out and define what needs to be considered prior to carrying out these activities.

1. Naturopathic Doctors are accountable and responsible when they make a decision that the patient's condition would benefit from an activity, and act within their scope of practice to perform the activity.
2. Naturopathic Doctors ensure that the activity they will perform is:
  - a. Within the scope of practice for naturopathic doctors as set out in the *Naturopathic Physicians Regulation*;
  - b. In the best interest of their patient's health;



- c. Consistent with CCHPBC's standards of practice including standards, limits, and conditions;
- d. Within the naturopathic doctor's individual competence.

3. Naturopathic Doctors ensure they have the competence to:

- a. Make decisions about whether the patient would benefit from the activity, having considered:
  - i. the known risks and benefits to the patient;
  - ii. the predictability of outcomes of performing the activity;
  - iii. other relevant factors specific to the patient or situation.
- b. Carry out the activity safely and ethically;
- c. Safely manage the intended and unintended outcomes of performing the activity.

4. Naturopathic Doctors identify the effect of their own values, beliefs, and experiences in decision-making, recognize potential conflicts, and take action for the needs of the patient to be met.

5. Naturopathic Doctors use a combination of empirical evidence and professional judgement to support their decision-making and the activity to be performed.

6. Naturopathic Doctors follow a clinical decision-making process to:

- a. Assess the patient's health status;
- b. Make a diagnosis of a patient condition that can be prevented, improved, ameliorated, or resolved through naturopathic doctor activities;
- c. Determine a plan of care;
- d. Determine an activity to be performed;
- e. Implement an activity to prevent, treat, or palliate an illness or injury and/or improve, ameliorate, or resolve a condition;
- f. Manage the intended and unintended consequences of carrying out the activity
- g. Manage and evaluate the outcomes of the activity.

7. Naturopathic Doctors communicate and collaborate with the patient (or their substitute decision-maker) about diagnoses, decisions, actions, and outcomes to support the patient to be an active participant in making informed decisions about the care to meet the patient's needs.

8. Naturopathic Doctors consult with, or refer patients to, other health care professionals when:

- a. the needs of the patient exceed their scope of practice or individual competence; or
- b. patient care would benefit from the expertise of other health care professionals.



9. Before performing an activity, naturopathic doctors consider available resources and human and system factors to safely perform the activity and to manage intended and unintended outcomes of the activity.



## **Part 2: Restricted Activities for Naturopathic Doctors: Limits and Conditions**

The purpose of this section of the document is to identify the CCHPBC Limits and Conditions assigned to the Restricted Activities granted to NDs in the Regulation.

**'Restricted Activities'** are higher risk clinical activities that must not be performed by any person in the course of providing health services, except members of a regulated profession that has been granted specific legislative authority to do so, based on their education and competencies.

**'Limits'** identify what NDs are not permitted to do.

**'Conditions'** identify the circumstances under which NDs may carry out an activity.

5 (1) (a) use naturopathic techniques to make a diagnosis identifying, as the cause of signs or symptoms of an individual, a disease, disorder or condition;

5 (1) (b) perform a procedure on tissue

- (i) below the dermis, or
- (ii) below the surface of a mucous membrane;

### ***CCHPBC Limits and Conditions***

1. *Registrants must hold CCHPBC certification in Acupuncture prior to engaging in acupuncture.*
2. *Registrants perform phlebotomy*
  1. *To collect blood samples for testing*
  2. *For therapeutic purposes*

5 (1) (c) move a joint of the spine beyond the limits the body can voluntarily achieve but within the anatomical range of motion using a high velocity, low amplitude thrust;

### ***CCHPBC Limits and Conditions***

*Registrants that practice Spinal Manipulation Therapy (SMT) must attend continuing education in SMT.*



5 (1) (d) administer a substance

- (i) by injection,
- (ii) by inhalation,
- (iii) by irrigation,
- (iv) by enteral instillation or parenteral instillation, or
- (v) using a hyperbaric chamber.

## **CCHPBC Limits and Conditions**

1. Registrants must have additional education<sup>i</sup> in **Facial Mesotherapy, Fat Reduction and Body Contouring** and current qualification in Naturopathic Advanced Life Support (NALS) prior to providing Facial Mesotherapy, Fat Reduction and Body Contouring.
2. Registrants must hold CCHPBC certification in **Cosmetic Botulinum Toxin and Prescriptive Authority** and current qualification in Naturopathic Advanced Life Support (NALS) prior to providing cosmetic botulinum toxin.
3. Registrants must hold CCHPBC certification in **Botulinum Toxin: Medical/non-Aesthetic and Prescriptive Authority** and current qualification in Naturopathic Advanced Life Support (NALS) prior to injecting botulinum toxin for medical/non-aesthetic purposes.

*Injections of botulinum toxin into intra-ocular muscles is prohibited.*

*This activity cannot be delegated to another person.*

*Registrants must only use botulinum toxin substances that are approved by Health Canada and are included in the pharmacopeia of naturopathic physicians with Prescriptive Authority.*

4. Registrants must hold CCHPBC certification in **Injectable Fillers and Prescriptive Authority** and current qualification in Naturopathic Advanced Life Support (NALS) prior to providing injectable fillers.

*Registrants must hold **Provisional 1 Injectable Fillers** certification or higher to utilize Hyaluronic Acid injectable fillers, and other injectable products used to*



*modify or manage the effects of hyaluronic acid filler, including hyaluronidase in the lips, cheeks, chin, marionettes, nasal folds (with cannula only) and jawline.*

*Registrants must hold **Provisional 2 Injectable filler certification** or higher to utilize any Health Canada approved injectable fillers (Hyaluronic acid, Biostimulators, and threads), and other injectable products used to modify or manage the effects of hyaluronic acid filler, including hyaluronidase into the glabella, forehead, nose (bridge, tip and nasolabial junction), pyriform, nasal folds (with needle), tear troughs, eyelids, temples and body. Emergency use of hyaluronidase is not restricted to any area when performed by any ND with competency.*

*Registrants must hold certification in **Injectable Fillers Provisional Level 2 or Level 2** with additional education<sup>1</sup> in threads prior to utilizing threads.*

*Injecting dermal fillers into the genitalia is prohibited.*

5. *Registrants must hold CCHPBC certification in **Platelet Rich Plasma (PRP)** and **Prescriptive Authority** and current qualification in Naturopathic Advanced Life Support (NALS) prior to injecting PRP below the dermis of the face, neck, scalp, and hands.*

*Registrants must hold CCHPBC certification in **PRP for Aesthetics purposes, Injectable Filler** and **Prescriptive Authority** and current qualifications in Naturopathic Advanced Life Support (NALS) prior to administering Plasma Gel/Platelet Rich Fibrin treatments. Registrants are subject to the restriction in treatment areas determined by their Injectable Filler certification level.*

6. *Registrants **do not** administer any substance via **hyperbaric oxygen chamber**.<sup>ii</sup>*
7. *Registrants must hold CCHPBC certification in **Ozone and Oxidative Therapies and Prescriptive Authority** and current qualification in Naturopathic Advanced Life Support (NALS) prior to engaging in ozone and oxidative therapies.*

*Depending on the approach to therapy, **IV Therapy Certification, IV and Chelation Therapies Certification** or **Advanced Injection Therapies Certification** may be required.*

8. *Registrants must hold CCHPBC certification in **Advanced Injection Therapies and Prescriptive Authority** and current qualification in Naturopathic Advanced Life Support (NALS) prior to engaging in advanced injection therapies.*



*Stromal Vascular Fraction injections, bone marrow injections, and related injections are prohibited.*

*Stellate ganglion blocks are prohibited.*

*Intra-vaginal injections and intra-cavernous injections are prohibited.*

*Devices used for advanced injection therapy must have an **Active Medical Device** licence from Health Canada (search Health Canada's Medical Devices Active Licence Listing by "Device name").*

5 (1) (e) put an instrument or a device or finger:

- (i) into the external ear canal, up to the eardrum
- (ii) beyond the point in the nasal passages where they normally narrow
- (iii) beyond the opening of the urethra
- (iv) beyond the labia majora,
- (v) beyond the anal verge, or
- (vi) into an artificial opening into the body.

## *CCHPBC Limits and Conditions*

1. *Registrants must hold certification in **Intrauterine Device (IUD) Insertion and Removal and Prescriptive Authority** prior to inserting an IUD.*
2. *Registrants who carry out pelvic exams or cervical cancer screening must possess the competencies established by the Provincial Health Services Authority (PHSA) and follow decision support tools established by PHSA.*

5 (1) (f) put into the external ear canal, up to the eardrum, a substance that is under pressure.

5 (1) (g) apply:

- (i) ultrasound for diagnostic or imaging purposes, including any application of ultrasound to a fetus,
- (ii) electricity for the purposes of destroying tissue in the course of minorsurgery, or defibrillation in the course of emergency cardiac care, or



(iii) X-rays for diagnostic or imaging purposes, excluding X-rays for the purpose of computerized axial tomography;

5 (1) (h) issue an instruction or authorization for another person to perform, in respect of a named individual, a restricted activity specified in paragraph (g) (i) or (iii);

## *CCHPBC Limits and Conditions*

*Delegating restricted activities is prohibited.*

5 (1). (i) in respect of a drug:

- (i) prescribe the drug,
- (ii) compound the drug,
- (iii) dispense the drug, or
- (iv) administer the drug by any method;

## *CCHPBC Limits and Conditions*

1. *Registrants must hold certification in **Prescriptive Authority**, have access to Pharmanet, and current qualification in Naturopathic Advanced Life Support (NALS) prior to prescribing, compounding, dispensing, or administering a drug.*

*Registrants document when and reasons why their treatment diverges from the clinical practice guidelines of BC Cancer when a prescribing cancer drug treatment*

*Registrants document when and reasons why their treatment diverges from the clinical practice guidelines of the BCCDC when treating STIs.*

2. *Registrants must hold certification in **Immunization and Prescriptive Authority** prior to prescribing or administering vaccines. Registrants must follow decision support tools established by the **BC Centre for Disease Control** when administering vaccines.*

*Naturopathic physicians only compound, dispense, or administer immunoprophylactic agents identified by the **BC Centre for Disease Control (BCCDC)**.*



*Registrants must not administer an immunization to a child under five (5) years old.*

3. *Registrants must hold certification in IV Therapy and Prescriptive Authority and current qualification in Naturopathic Advanced Life Support (NALS) prior to engaging in IV therapy.*

*Registrants must hold certification in IV Therapy and Chelation Therapies prior to engaging in chelation therapy.*

*Registrants must obtain additional education<sup>1</sup> in intravenous (IV) and intramuscular (IM) iron prior to administration of IV and IM iron.*

*Registrants must have additional education<sup>1</sup> in peripherally inserted central catheters (PICCs) and ports prior to accessing existing PICCs and ports.  
Registrants do not insert PICCs or ports.*

5 (1) (j) if nutrition is administered by enteral instillation or parenteral instillation

- (i) select ingredients for a therapeutic diet,
- (ii) compound a therapeutic diet, or
- (iii) dispense a therapeutic diet

5 (1) (k) conduct challenge testing for allergies

- (i) that involves injection, scratch tests or inhalation, if the individual being tested has not had a previous anaphylactic reaction, or
- (ii) by any method if the individual being tested has had a previous anaphylactic reaction

## **CCHPBC Limits and Conditions**

*Registrants must have current CCHPBC certification in Prescriptive Authority, additional education, current qualifications in Naturopathic Advanced Life Support (NALS) and emergency equipment in place including epinephrine.*

5 (1) (l) conduct desensitizing treatment for allergies

- (i) that involves injection, scratch tests or inhalation, if the individual



being tested has not had a previous anaphylactic reaction, or

(ii) by any method if the individual being tested has had a previous anaphylactic reaction.

## **CCHPBC Limits and Conditions**

*Registrants must have current CCHPBC certification in Prescriptive Authority, additional education<sup>1</sup>, current qualifications in Naturopathic Advanced Life Support (NALS) and emergency equipment in place including epinephrine.*

6 (1) A registrant may perform only surgery that is minor surgery.

**"minor surgery"** means a surgical procedure that

(a) is performed, for a diagnostic or therapeutic purpose, on a superficial anatomical structure, and

(b) does not involve:

(i) sedation, general anaesthesia or respiratory assistance, or

(ii) a material risk to life.

## **CCHPBC Limits and Conditions**

*Must have successfully completed the Etonogestrel Extended Release Subdermal Implant Clinical Training Program, hold certification in Prescriptive Authority and current qualification in Naturopathic Advanced Life Support (NALS) prior to prescribing, inserting and/or removing the etonogestrel extended release subdermal implant.*

*Registrants prescribing Etonogestrel Extended Release Subdermal Implants must be available to insert them.*

*Fistulotomies, fistulectomies or any other procedures that involve the cutting of tissue beyond the anal verge or on any other non-superficial anatomical structure are prohibited.*

*The surgical procedures vasectomy, circumcision, and penile frenulectomy are prohibited.*

## **PART 3 Limits and Condition on Activities that are not restricted**

Many activities that naturopathic doctors carry out do not involve performing restricted activities. The *Naturopathic Physicians Regulation* includes these activities in the broad scope of practice statement.

CCHPBC has established limits and conditions for the following activities that are not restricted:

### **CCHPBC Limits and Conditions**

1. Registrants must have additional education<sup>1</sup> in **Microdermabrasion and Chemical Peels** prior to providing Microdermabrasion and Chemical Peels.
2. Registrants must have additional education<sup>1</sup> in **Photorejuvenation and High Frequency Electromagnetic Treatments** prior to providing Photorejuvenation and High Frequency Electromagnetic Treatments.

#### **For Laser use:**

1. Registrants must ensure that all laser devices used are approved by Health Canada
2. Registrants obtain additional training prior to utilizing laser
3. Registrants must not delegate the use of lasers
4. Registrants do not use laser for the purpose of cutting and destroying tissue which includes but is not limited to:
  - a. lasers used for the treatment of cancer including tumor removal, such as carbon dioxide lasers, Nd:YAG (Neodymium: Yttrium-Aluminum-Garnet) lasers;
  - b. lasers used to remove polyps such as Argon lasers;
  - c. lasers used for photodynamic therapy or PDT;
  - d. lasers used for laser-induced interstitial thermotherapy;
  - e. lasers used for the removal of warts; and
  - f. lasers used for the treatment of periodontal disease.
5. Registrants who utilize Class 3B or Class 4 LASERS must ensure compliance with existing standards and occupational health and safety regulations including:
  - a. CSA Z386 Safe Use of Lasers in Health Care;
  - b. ANSI Z136.3 Safe Use of Lasers in Health Care; and
  - c. WorkSafeBC Occupational Health and Safety (OHS) Regulation – Part 7 Division 3 Radiation Exposure. AND
6. All individuals working in a laser-controlled area are responsible for maintaining safe



*practices. All settings in which lasers are used must have an identified person (for example, naturopathic physician) who assumes overall responsibility for the safe use of lasers and compliance with laser hazard controls. This individual has the responsibility for ensuring that:*

- a. Administrative control measures must be in place to support the safe use of lasers, including the appointment of an appropriately qualified laser safety officer (LSO) in all settings where class 3B and/or class 4 lasers are used. The minimum training requirements for the LSO are specified in CSA Z386 Safe Use of Lasers in Health Care.*
- b. All personnel possess the appropriate level of laser education and training based upon their role (e.g. laser user, laser operator, observer) in the laser-controlled area – as set out in the CSA Z386, Annex E.*
- c. A comprehensive laser safety program is in place (see section 6.3.1 of the CSA Z386 Safe Use of Lasers in Health Care).*
- d. A hazard analysis and risk assessment has been completed for each laser system, including when there is a new laser, when laser equipment is replaced, and in the event of a laser safety incident.*
- e. Procedural, environmental, and engineering control measures have been taken based on relative hazards to ensure the safe use of lasers; this includes the responsibility of ensuring a laser safety program is established and maintained in accordance with current standards.*
- f. There is a mechanism in place for evaluating the effectiveness of and compliance with the laser safety program.*

**7. All registrants providing laser therapy must ensure that:**

- a. Laser equipment is set up and routinely monitored for safe operation.*
- b. The area in which the laser is used provides a safe environment to address beam hazards (e.g., tissue interaction, skin damage, eye damage, fire) and non-beam hazards (e.g., electrical, gases/dyes).*
- c. They possess the appropriate level of laser safety training and are competent in the safe use of the laser system being used for patient care and/or treatment. Laser safety education must be current and updated at a minimum every 2 years (see Annex E of the CSA Z386 Safe Use of Lasers in Health Care).*
- d. Appropriate eye protection and personal protective equipment (PPE) is used to eliminate, or control hazards associated with the laser system being used.*
- e. Prior to any laser procedure, they will obtain informed consent from the patient as per the Practice Standard: Informed Consent.*
- f. Appropriate documentation is done in the patient's medical record, which includes accurate account of the patient's status, the laser system parameters and settings, the actions of the laser team and the patient's outcome.*

<sup>i</sup> “Additional education” is structured education, e.g., workshop, course, program of study, designed so that registrants can attain the competencies required to carry out a specific activity as part of naturopathic practice. Additional education builds on the entry-level competencies of naturopathic doctors; identifies the competencies expected of learners on completion of the education; includes both theory and application to practice, and includes an objective, external evaluation of learners’ competencies on completion of the education. The term does not refer to a course or program approved for a CCHPBC certification.

<sup>ii</sup> NDs are not permitted to utilize hyperbaric oxygen chambers
