



Spring 2026 Registration Examination

The next registration examination will be held in Spring 2026.

Applications for the Spring 2026 registration examination will be processed from **Monday, November 17, 2025.**

The deadline for the application, including related documents and payment, must be received **by 12 pm (noon) PDT on Friday, December 12, 2025.**

Candidates are required to complete three components of the registration examination:

- Online exam: Clinical Knowledge and Theory
- Performance-Based Assessment (practical exam)
- Online exam: Law, Ethics and Professionalism

Theory Exam: Clinical Knowledge and Theory

Date: February 23 OR February 24, 2026

Time: Three hours

Locations:

- Metro Vancouver
- Okanagan Valley
- Vancouver Island

The exam is held in a proctored computer lab. Venue details will be provided by email to exam candidates prior to the exam date.



Performance-Based Assessment

Candidates can choose to attend the Performance-Based Assessment (PBA) on any one of the dates in the following weeks:

Week 1: March 2 – 6, 2026

Week 2: March 9 – 13, 2026

The Performance-Based Assessment (PBA) will be held in Burnaby (Metro Vancouver). Venue information will be provided by email to exam candidates prior to their exam date.

Law, Ethics and Professionalism

The LEP course will consist of seven (7) modules. At the end of each module, applicants must successfully pass an end-of-module quiz to progress to the next module. All materials and resources required to succeed are provided within each module. Successful completion of all seven (7) modules, with a score of 100% in each end-of-module quiz, is a pre-requisite to take the LEP exam.

Candidates are advised to begin the Law, Ethics and Professionalism course at their earliest opportunity.

Completion of the 7-module online course **by 12 PM (noon) PDT on Wednesday, February 18, 2026**, is a pre-requisite to the online LEP exam.

The exam is held in a proctored computer lab.

CCHPBC Registration Examination scheduling

CCHPBC's registration examination is generally held twice a year: once in late winter/spring and once in late summer/fall.
